

SUMMER OF WINNING PHASE #1-SUMMER SIZZLIN' SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Summer of Winning Phase #1 ("Summer Sizzlin'") (the "Sweepstakes") is open to legal residents who (1) reside in the following counties: Banner, Box Butte, Cheyenne, Dawes, Deuel, Garden, Grant, Kimball, Morrill, Scotts Bluff, Sheridan, and Sioux in Nebraska, or Goshen, Laramie, Niobrara, and Platte in Wyoming, and who (2) are at least nineteen (19) years old at the time of entry. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within thirty (30) days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
