# CRACK THE VAULT OFFICIAL CONTEST RULES

# NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

# 1. Eligibility

The Crack The Vault Visible Vault Contest ("Crack The Vault") (the "Contest") is open to legal residents of the United States who are at least 19 years of age or older on the date of entry. Employees of the Nebraska Rural Radio Association, or other official sponsors associated with the Contest of the Contest (listed in section 2), and their respective parents, subsidiaries, affiliates, and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations. Void where prohibited.

# 2. Sponsor

The Contest is sponsored by the Nebraska Rural Radio Association, located at 1928 East Portal Place, Scottsbluff, Nebraska, 69361 (the "Sponsor").

# 3. Agreement to Official Rules

By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Sponsor, as final and binding as it relates to the content. The Contest is subject to all applicable federal, state and local laws.

## 4. Contest Period

The Contest begins on June 1, 2025, and runs through September 30, 2025, or after five thousand (5,000) attempts have been completed, whichever is sooner.

#### 5. How to Enter

The Contest must be entered by stopping by an on-location appearance at the date and time announced on air, online and/or on social media. A random six digit number ("Prize Determination Number") has been randomly selected from the range of 000,000 to 999,999 and programmed into the Visible Vault. Each contestant is permitted only one (1) attempt to open the Vault. Make your attempt by entering a number of exactly six digits into the Vault's lock. If the number you enter as your attempt is identical (exact order) to the Prize Determination Number, you are a winner, subject to verification.

#### 6. Prizes

Grand Prize: \$100,000. Up to two Grand Prizes are available to be won. If no one enters the Prize Determination Number, no Grand Prize will be awarded. Each person that attempts an entry will be given a \$1 Nebraska Lottery scratch ticket as a second-place prize. The prize is non-transferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others is permitted. Acceptance of prize constitutes permission for Sponsor to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

# 7. Odds

The odds of winning are 0.0002% per attempt.

#### 8. Winner Selection and Notification

The memory of the Vault's lock is the sole determiner of (i) each number entered as an attempt and (ii) the Prize Determination Number. Not responsible for any Vault or lock malfunction. A contestant's sole remedy in the event of any Vault or lock malfunction will be a replacement entry. In the event a winner is claimed, an Affidavit of Eligibility and Liability/Publicity Release must be signed by the claimed winner and submitted to Sponsor.

# 9. Rights Granted By You

By entering this content you understand that Sponsor, anyone acting on behalf of Sponsor, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Contest, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

# 10. Limitation of Liability

By entering you agree to release and hold harmless Sponsor and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Contest; (v) electronic or human error which may occur in the administration of the Contest or the processing of entries.
